

EIGHTH DISTRICT

Part of the City of Virginia Beach comprised of the North Beach, South Beach, Linkhorn, Alanton, London Bridge, Cape Henry, Plaza, Holland, Capps Shop, Windsor Oaks, Kings Grant, Wolfsnare, Lynnhaven, Oceana, Magic Hollow, Landstown, Hunt, Eastern Shore, Hilltop, Strawbridge, Ocean Lakes (3)/Red Wing (30)/Sigma (31)/Culver (63), Seatack (5)/Rudee (72), and Trantwood (9)/Great Neck (10) Precincts and parts of the Courthouse and Little Neck Precincts. (2001, Sp. Sess. I, c. 2; § 24.2-303.1.)

All references to precincts shall be interpreted to refer to those in existence on April 1, 2001, and as reported by the United States Bureau of the Census in the 2000 Census reports provided pursuant to United States Public Law § 94-171.

The following description is provided for information purposes only pursuant to § 24.2-301 of the Code of Virginia. The provisions of § 24.2-303.1 of the Code of Virginia, including the statistical report referenced therein and on file with the Clerk of the Senate of Virginia, shall be controlling in any legal determination of the district boundary.

Part of the City of Virginia Beach east of a line described as follows:

1. Beginning at the point on the City of Virginia Beach-Northampton County boundary in the Atlantic Ocean and Chesapeake Bay due north of the mouth of Lynnhaven Bay
2. south to the mouth of Lynnhaven Bay crossing the John A. Lesner Bridge and continuing south through Lynnhaven Bay to Advance Road
3. south on Advance Road to Lynnwood Drive
4. east and then north on Lynnwood Drive to Lamorelle Lane
5. east on Lamorelle Lane to Harris Road
6. south on Harris Road to Little Neck Road
7. southeast and then south on Little Neck Road, crossing Virginia Beach Boulevard (United States Highway 58), to North Plaza Trail
8. south on North Plaza Trail and continuing south and then west on South Plaza Trail to South Rosemont Road
9. south on South Rosemont Road to Silina Drive

10. west on Silina Drive to South Plaza Trail
11. southwest on South Plaza Trail to Holland Road (State Highway 410)
12. east on Holland Road to South Rosemont Road
13. south on South Rosemont Road to Dahlia Drive
14. east on Dahlia Drive to Upland Road
15. north and then northeast on Upland Road to Smoke Tree Lane
16. east on the southern roadway of Smoke Tree Lane and then north on Smoke Tree Lane to Stoneshore Road
17. east on Stoneshore Road to Holland Road
18. southeast on Holland Road to Dam Neck Road
19. southwest on Dam Neck Road to Princess Anne Boulevard (State Highway 165)
20. southeast on Princess Anne Boulevard to James Madison Boulevard
21. southwest on James Madison Boulevard to George Mason Drive
22. southeast on George Mason Drive to North Landing Road
23. west on North Landing Road to West Neck Road
24. south on West Neck Road to Indian River Road
25. east on Indian River Road to West Neck Creek
26. south on West Neck Creek to North Landing River
27. southwest on North Landing River (including a portion of the City of Virginia Beach-City of Chesapeake boundary) and then south on the North Landing River approximately 3.1 miles to a tributary of the River
28. east on the tributary of the North Landing River approximately 1 mile to South Stowe Road
29. east on South Stowe Road to Princess Anne Road
30. north on Princess Anne Road to Mill Landing Road

31. east on Mill Landing Road to Nawney Creek Road
32. northeast on Nawney Creek Road to Nawney Creek
33. southeast on Nawney Creek to Back Bay
34. east and then south through Back Bay to the Virginia-North Carolina state line.
